1. Saya adalah Defendan yang dinamakan di atas dan merupakan Presiden Parti Pribumi Bersatu Malaysia ("BERSATU") pada masa ini.
2. Saya mengikrarkan afidavit ini bagi menentang permohonan Plaintiff untuk injunksi interlokutori dalam Notis Permohonan bertarikh 20.04.2022 (Lampiran 3) yang telah difailkan oleh Plaintiff dan selanjutnya, sebagai sokongan kepada pernyataan saya dalam afidavit-afidavit berikut:

3. Kecuali yang dinyatakan sebaliknya, perkara-perkara yang dideposkan di sini adalah dalam pengetahuan dan kepercayaan peribadi saya dan/atau diperoleh dari rekod yang saya mempunyai akses.
  4. Saya difahamkan bahawa Mahkamah yang Mulia ini telah mengarahkan bahawa tiada afidavit lanjutan difailkan oleh pihak-pihak berkenaan dengan Permohonan Injunksi Plaintif. - b) Terdapat sesalinan surat yang dihantar ke Istana yang menunjukkan sokongan kepada Dato' Seri Haji Anwar bin Ibrahim sebagai Perdana Menteri;
- c) Bahawa Plaintiff merupakan seorang pembohong dan beliau telah berbohong kepada ahli-ahli partinya dan kepada masyarakat awam.

10. Hakikatnya, pengesahan Dato' Sri Haji Tajuddin bin Abdul Rahman menunjukkan bahawa Plaintiff telah secara terang-terangan berbohong kepada Mahkamah yang Mulia ini dalam affidavit Plaintiff apabila beliau menafikan telah mengisru surat di Ekshibit "TSMY-1" dalam Affidavit Jawapan Defendan tersebut.

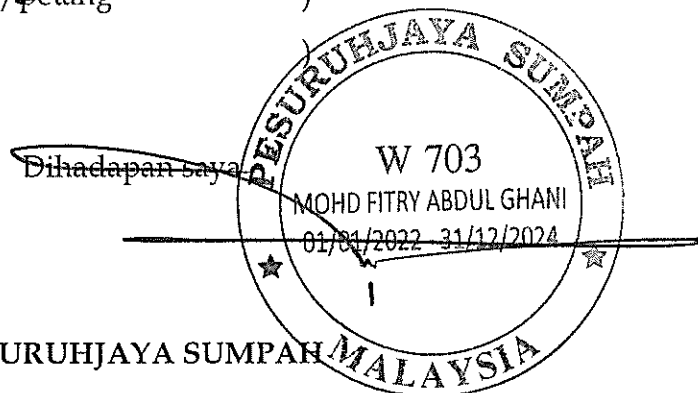

I, TAN SRI DATO' HAJI MAHIADDIN BIN HAJI MD YASIN (NRIC No.: 470515-01-5401), a Malaysian citizen of full age with an address of service at No. 5 Jalan Setiabakti 7, Bukit Damansara, 50490 Kuala Lumpur, do hereby solemnly and sincerely affirm and state as follows:-

1. I am the above named Defendant and the current President of Parti Pribumi Bersatu Malaysia ("BERSATU").
2. I affirm this affidavit in opposition to the Plaintiff's application for an interlocutory injunction in the Notice of Application dated 20.04.2022 (Enclosure 3) which has been filed by the Plaintiff and in further support to the position that I have stated in the following affidavits:-
  - a) Defendant's Affidavit in Reply affirmed on 26.4.2022;

- b) Defendant's Affidavit in Reply No. 2 affirmed on 1.6.2022;
  - c) Affidavit in Support of the Defendant affirmed by Dato' Seri Azmin Mohamed Azmin bin Ali on 1.6.2022.
3. Save where stated to the contrary, the matters deposed herein are within my personal knowledge and belief and/or obtained from records to which I have access.
4. I was made to understand that this Honourable Court has directed that no further affidavits to be filed by the parties in relation to the Injunction Application by the Plaintiff. However, I state that new evidence has since emerged and this evidence was not available at the time the above stated affidavits were filed.
5. I state that on or about 27.6.2022, Dato' Sri Haji Tajuddin bin Abdul Rahman has held a press conference after he was sacked from the UMNO Supreme Council.
6. At the press conference, Dato' Sri Haji Tajuddin bin Abdul Rahman stated, among others, that:-
- a) He was forced to signed a statutory declaration by the Plaintiff to support Dato' Seri Haji Anwar bin Ibrahim as the Prime Minister;
  - b) There was a letter sent to the Palace indicating support of Dato' Seri Haji Anwar bin Ibrahim being elected as the Prime Minister;
  - c) That the Plaintiff is a liar and he had lied to his party members and the public.

7. The press conference given by Dato' Sri Haji Tajuddin bin Abdul Rahman was re-published by Malaysia Kini titled "*Tajuddin: Zahid's 'no DAP, No Anwar' mantra is a lie*" and Malaysia Today titled "*Tajuddin Dedah Ahli Parlimen UMNO Tandatangani SD Sokong Anwar Jadi PM*".

8. In fact, Dato Seri Nazri Abdul Aziz confirmed that he was one of the UMNO leaders who signed the statutory declaration to support Dato' Seri Haji Anwar bin Ibrahim as the Prime Minister at the material time.

9. I state that the statements by Dato' Sri Haji Tajuddin bin Abdul Rahman and Dato Seri Nazri Abdul Aziz further confirmed the facts and the truth that I have deposed to in my affidavits.
10. In fact, the confirmation by Dato' Sri Haji Tajuddin bin Abdul Rahman demonstrates that the Plaintiff had blatantly lied to this Honourable Court in his Affidavit when he denied issuing the letter at Exhibit "TSMY-1" of the Defendant's Affidavit in Reply.
11. I note that the Plaintiff did not deny the statements made by Dato' Sri Haji Tajuddin bin Abdul Rahman. His response was merely that he respected the statements that were made and he left it to the UMNO members to decide on the truth of the statements made by Dato' Sri Haji Tajuddin bin Abdul Rahman.

According to Dato' Sri Haji Tajuddin bin Abdul Rahman, the Plaintiff threatened his members against speaking up and warned them that they will not get the *surat watakah* to contest in the next General Election should they speak up.





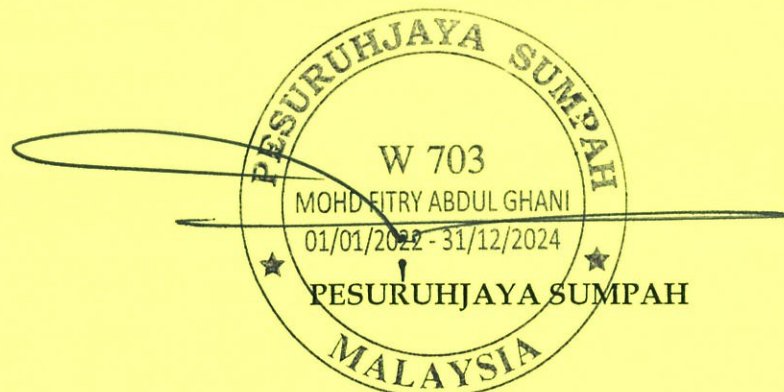

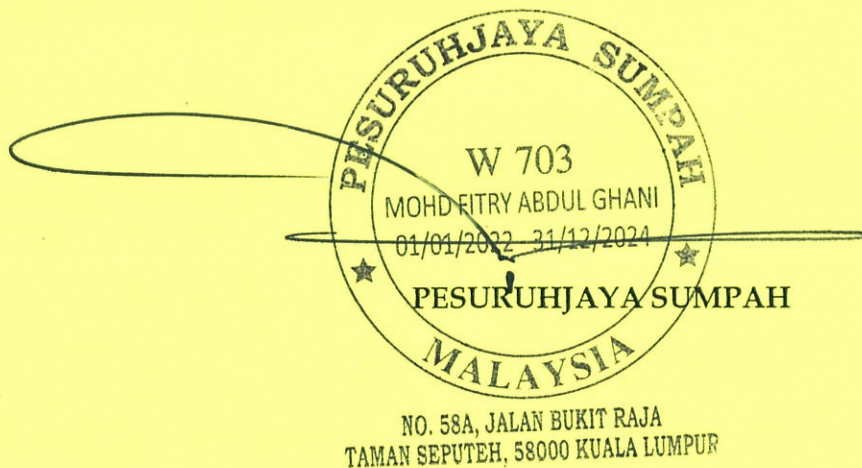

## Tajuddin: Zahid's 'no DAP, no Anwar' mantra is a lie

Umno president Ahmad Zahid Hamidi's oft-repeated "No DAP, no Anwar" mantra was a lie, according to recently dropped Umno supreme council member Tajuddin Abdul Rahman.

At a press conference in Kuala Lumpur today, Tajuddin (*above*) said he was a "living witness" to Zahid signing a statutory declaration backing PKR president Anwar Ibrahim as prime minister.

"On the '*jajaran baru*' (new alignment), 'oh no Anwar, no DAP'. Come on! I am a living witness... Don't deny it. There were statutory declarations (stating) support for Anwar as prime minister signed.

"The letters were addressed to Istana Negara. I was asked to sign it as well. I refused. In the end, (when Zahid) was about to



pout, I signed. I'm a living witness.

"When the matter was exposed, (Zahid) was questioned. He replied 'no DAP, no Anwar, no PKR'. It's all lies. He lied to Umno members. The public doesn't know this.

"I pity the ordinary Umno members. They just (accept it) because they respect the president. They can't go against him," said Tajuddin.



According to Tajuddin, Zahid also tried to form a government with Dr Mahathir Mohamad before agreeing to do so with Muhyiddin Yassin.

"I didn't agree with joining Mahathir because it didn't benefit Umno. At the time, we were getting stronger as the opposition. We were ready for the 15th general election.

"(Later) I was forced to take a stand. I was forced to voice out about 'the new alignment'. Don't say you didn't do it. It was at a hotel in Kampung Baru where the signing (of documents) took place.



“I sat there waiting to sign as well,” he added.

Tajuddin was speaking at a tell-all press conference following Zahid’s decision to dismiss him from the party’s supreme council.

Zahid co-opted Tajuddin into the supreme council in 2018. No reasons were given for Tajuddin’s removal.

During the Umno annual delegates assembly in March, Zahid had adopted a “No DAP, No Anwar, No Bersatu” policy and said he never negotiated with any of the three entities he mentioned.

PKR claims vindication

In late 2020 and early 2021, Anwar had claimed that he had the numbers to form a new government that is “convincing, formidable and strong” - implying that there were defections.

However, the claim became a subject of ridicule when the support failed to materialise.

Zahid’s statement in September 2020 also lent credence that Anwar was seeking defections from BN.

By April 2021, there were allegations that Anwar called Zahid after the Umno delegates assembly to congratulate him.

In hindsight, Anwar told an interview in April that the support fell apart because he refused to compromise on certain principles, such as by declining to give free out-of-jail cards to politicians who are facing criminal trials.

Meanwhile in a statement today, PKR information chief Shamsul Iskandar said Tajuddin’s statement has vindicated Anwar’s claims at the time.

“Thus, people who ridiculed Anwar for supposedly lying about the formidable and convincing support for him on Sept 22, 2020, now have their answer.



“Tajuddin’s statement today also reveals the betrayal and personal agendas that have foiled efforts to retake Putrajaya.

“We should never give space and compromise with leaders accused and convicted in court for appalling corruption and abuse. They must have their day in court for justice to take its course,” he added.

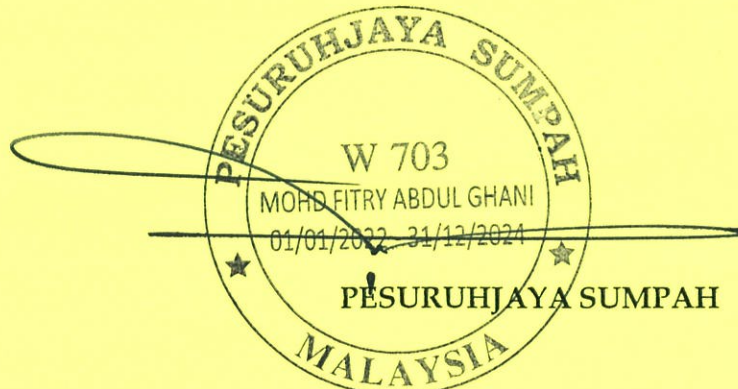

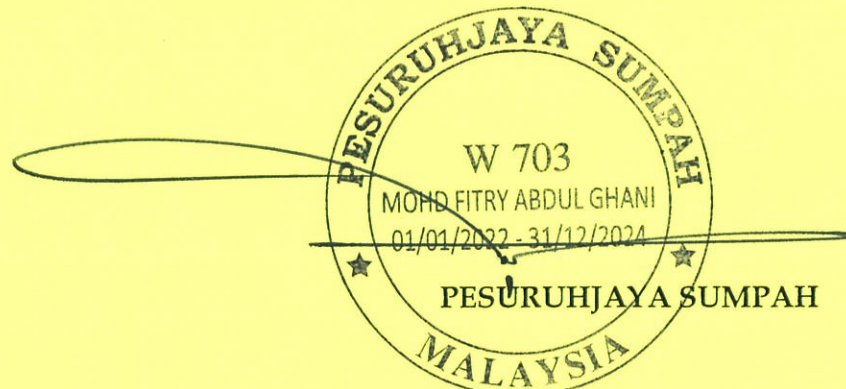

## After Tajuddin's tell-all, Zahid passes buck on punishment to Umno disciplinary panel

KUALA LUMPUR, June 28 — Umno president Datuk Seri Ahmad Zahid Hamidi sidestepped questions today about possible action against removed supreme council member Datuk Seri Tajuddin Abdul Rahman who publicly criticised him and the party yesterday.

Instead, Zahid said such matters came under the authority of the

party's disciplinary board, on whose recommendation the Umno supreme council would then act.

"I also respect the party's constitution, where there is a disciplinary board.

"If the disciplinary board receives a report or request for any investigation for an action to be taken, then any recommendations by the disciplinary board will be considered and decided by the supreme council," he told reporters when met at the court complex here after his trial's proceedings.

Asked about Tajuddin's claim yesterday that Zahid himself had started a movement by Umno MPs in 2021 to sign statutory declarations to support PKR president Datuk Seri Anwar Ibrahim as prime minister, he pointed out that the former no longer sat in Umno's supreme council and was only an appointed supreme council member.

Zahid also highlighted that he has the discretion as Umno president to decide on membership in the Umno supreme council, which is the party's highest leadership body.

"I respect whatever statements that are made, but the main thing is that he is no longer a supreme council member," he said.

"He was appointed as a supreme council member on appeal, as he lost as Umno vice-president, therefore his appointment was according to articles in Umno's constitution that gives the Umno president the power to appoint someone — as long as they are an Umno member — to sit in the supreme council. So it is also up to that clause, whether to appoint, or to terminate, or to replace that vacant position with someone else, which is also according to the clause in Umno's constitution."

Zahid also said he leaves it to Umno's members to consider whether there was any truth in Tajuddin's remarks.

"To me, anything that is stated by him, whether it is not true or there is a bit of truth, I leave it to Umno members, especially those in the grassroots to make the appropriate evaluation on the position of someone as a supreme council member, whether they were elected in elections or appointed according to clauses, or also present in the supreme council as they represented the state liaison — namely as a state liaison chairman — who did not win or



was not appointed to the supreme council, as the appointed positions are already filled.

"That is the discretion of the president and the supreme council to give someone the opportunity to also be present in meetings at the supreme council, but they cannot vote if there is voting in any supreme council meetings. Instead, it is open for them to give their views or opinions, whether they agree, are neutral or do not agree."

Yesterday, Tajuddin alleged that 15 Umno MPs had signed the SD to support Anwar including himself.

He alleged that the list of the 15 MPs who had signed the SDs at the Tamu Hotel in Kampung Baru here included Umno president Datuk Seri Ahmad Zahid Hamidi, Pekan MP Datuk Seri Najib Razak, and Padang Rengas MP Datuk Seri Nazri Aziz.

In response, PKR information chief said Datuk Seri Shamsul Iskandar Mohd Akin said the revelation validated Pakatan Harapan's bid to retake the federal government and proved that Anwar had sufficient amount of support from MPs to hold the majority in the Parliament and hence form a government back in 2020 following the so-called "Sheraton Move".

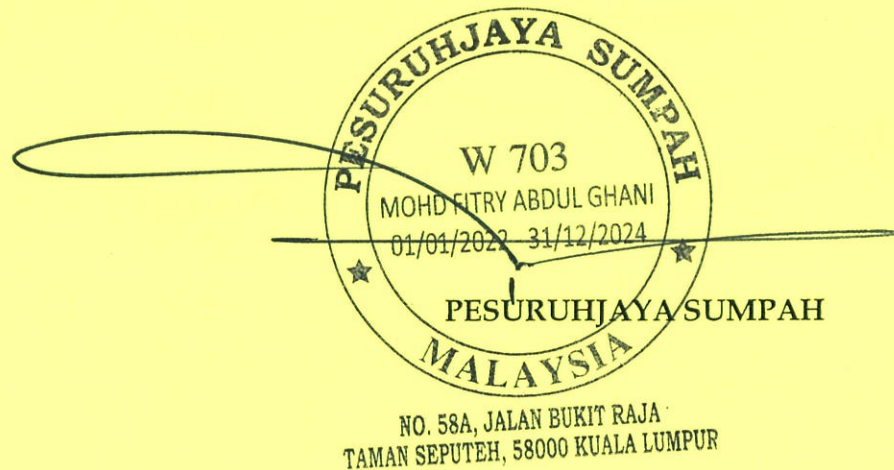

# 130 division chiefs wanted Zahid out, claims Tajuddin

PETALING JAYA: Pasir Salak MP Tajuddin Abdul Rahman has claimed that the majority of Umno division chiefs wanted party president Ahmad Zahid Hamidi to step down from his post in 2020.

At a press conference, the former Umno Supreme Council member said there was even a movement to pressure Zahid to step down involving 130 division chiefs. There are 191 Umno divisions.

Tajuddin said Zahid had been running the party like a one-man show, with decisions by the Umno Supreme Council heavily influenced by the president and council meetings held just "for show".

As such, this led to a movement within the party to submit a memorandum to Zahid – who Tajuddin described as a “liability to Umno” – for him to step down as president.

He alleged that the movement was led by Umno deputy president Mohamad Hasan. Tajuddin also named former prime minister Najib Razak, Umno Youth chief Asyraf Wajdi Dusuki and Umno vice-president Khaled Nordin as others involved in the movement. He claimed the Umno leaders had a meeting at his home to discuss the matter.

He added, however, that the push for Zahid’s resignation failed as Mohamad, also known as Tok Mat, backtracked on his intention to hand over the memorandum to the Umno president.

Earlier, Tajuddin urged Zahid to resign as Umno president “for the sake of the party” and claimed the Bagan Datuk MP was unhappy that he could not become prime minister last August, with Umno vice-president Ismail Sabri Yaakob getting Umno’s mandate instead.

Tajuddin also accused Zahid of only wanting to hold on to power.

“I suggest that Zahid just focuses on his court cases. He cannot take care of Umno,” he said.

Tajuddin also called Zahid a liability to Umno, saying he would lead the party to defeat if he was at the helm in the next general election (GE15).

He then claimed that the Umno president had threatened members against speaking up, warning them that “they will not get the letters of candidacy (surat watakah)” to contest in GE15 if they did.

On his removal as Supreme Council member last week, Tajuddin said that Zahid as president had “absolute power” to make the decision.

“There is no issue there. That is his right and it is alright with me. I accept it,” he said.

He added, however, that his termination letter did not state any reason for his removal.

“This means there was no issue or offence committed. But when speaking to the media, it’s a different story,” Tajuddin added.

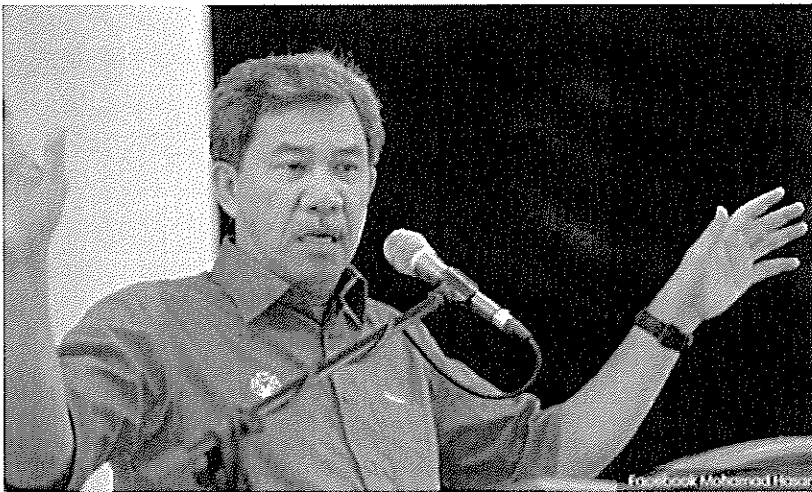
